

Riverview Health Emergency Room & Urgent Care Supports Conner Prairie with a \$5,000 Donation for AED/Cardiac Devices

Medical Facility Assists with Cardiac Safety Measures for Cultural Destination

FISHERS, Ind. (September 10, 2020) – To support Fishers EMS and Fishers Fire Department, <u>Riverview</u> <u>Health Emergency Room & Urgent Care</u> donated \$5,000 to <u>Conner Prairie</u> to support the facility's efforts to house automated external defibrillator (AED) machines throughout the complex for guests who experience sudden cardiac arrest.

Conner Prairie is a unique historic place that inspires curiosity and fosters learning by providing engaging and individualized experiences for everyone. Every year the museum sees hundreds of thousands of visitors, and with the recent implementation of <u>safety</u> <u>practices</u> due to the novel coronavirus, further measures are being taken to strengthen best practices for individuals with other medical concerns. With the suggestion and support from local first responders, Riverview Health ER & Urgent Care provided a donation in support of these changes—the funds will go toward machines that help restart a person's heart during a medical emergency.

Because cardiac arrest must be addressed swiftly, AEDs are a common piece of equipment found in public spaces, offering support to community members in the event of sudden cardiac arrest. According to the American Heart Association, cardiac arrest can happen

unexpectedly to anyone at any time and <u>is caused</u> when the heart's electrical system malfunctions, producing abnormal heart rhythms that make the heart stop pumping blood. AEDs are used to deliver an electrical shock to the heart to restore its normal rhythm. The electrical shock is known as a defibrillation and is time-sensitive to individuals who go into cardiac arrest. <u>Early signs</u> that an individual is going into cardiac arrest include having a racing heart, lightheadedness or dizziness, or a sudden loss of consciousness. More than 356,000 people of all ages experience out-of-hospital cardiac arrests annually in the United States.

"Riverview Health ER & Urgent Care is proud to be able to supply AEDs to Conner Prairie. These are important tools to have in public spaces," said Seth Warren, Riverview Health president and CEO. "While part of our efforts to support the health and safety of Hamilton County focus on taking care of our current patients, we also understand that should an immediate emergency like cardiac arrest arise, Hoosiers should have access to technology that can ultimately save their lives. We're proud to support Conner Prairie for their endeavors to educate, entertain, , and most importantly, find opportunities to ensure public safety."

While training is offered to use AEDs in the medical field, AEDs don't require officiated training to be used in public due to the device's ability to give verbal instructions to its users. Many machines hang on the wall and are removable when needed. Once a device is turned on, users must follow the voice prompts to properly administer care. Included with the device are padded electrodes, an adapter and a battery. Users attach the pads to the chest of the person suffering from cardiac arrest and signals are sent to the processor to analyze the heart's rhythm to determine if a defibrillation shock is needed. Depending on the device, the AED will automatically send a shock or voice commands will promptly announce when a button should be pressed to deliver it.
