In the huge U.S. IRA market, now valued at \$6.5 trillion, investors are diversifying their asset mix of mutual funds, equities and bonds with other products, including precious metals, Hanlon notes. Asset diversification has been recommended for generations by investment advisors, who typically suggest accumulating up to five percent of total assets in precious metals to hedge against inflation and protect against stock market declines. Assets held in Traditional, SEP, Simple, and Roth IRAs are eligible for transfer into physical metals. Transfers do not result in taxes or penalties.
